Editorial Guidelines

- Co-authorship: Max 2 co-authors
- References: Format of in-text citations following the ISO 690: 2010 (First Element & Date) standard.
- No references are allowed whether in the format of endnotes or footnotes.
- However, footnotes providing further information or subjective notes are allowed.
- The standard of any manuscript submitted to ISAIL is decided on the basis of the Research Writing Guidelines and the Editorial Guidelines for Authors. Please refer to isail.in/publications for more details and reference.
- All submissions, after due registration – shall be mailed at editorial.isail@gmail.com with Subject as “IJAIL Essay 2021 - <Name of Author> - <Date of Submission in DD-MM-YYY format>” along with the Ticket received – which confirms your registration in the competition.
- In the mail of submission, you have to mention your name, affiliation, email ID and phone number only. Further details based on circumstances will be mentioned effectively.

Prizes & Benefits

- Authors of the top 25 essays will get a merit certificate and an Internship Opportunity with ISAIL
- Authors whose works get the ranks of the Top 3 essays will also get a cash prize as follows:-
 - 1st Prize – 2,500 INR
 - 2nd Prize – 1,000 INR
 - 3rd Prize – 500 INR
- Top 5 essays may be published in the next Issue of IJAIL. Other entries may be considered for publication in any publication run by the Indian Society of Artificial Intelligence and Law if according to the decisions made by the Editorial Board of IJAIL, they seem fit for publication.

Who can participate?



Indian Students who are pursuing their LLB degrees (3 year course) or Integrated LLB degrees (5/7 year course/BA LLB/BSc LLB/BBA LLB/BTech LLB/others) (pursuing a law degree from a recognised university) can participate.

Open to all foreign students (pursuing a law degree from a recognised university)· Open to scholars, professors and advocates
